APPELLANT'S DECLARATION: SUPPLEMENT TO DECEMBER 26, 2016 REQUEST

Pursuant to 28 U.S.C. § 1746, I declare under the laws of the United States of America under penalty of perjury that the foregoing statements are true and correct. I understand false statements could result in the suspension or revocation of my non-interim TOP SECRET security clearance full adjudicated and issued on December 16, 2016.

- I have obtained previously unavailable evidence that bolsters my request for \$300,000 in compensatory damages.
- The evidence supports the egregious whistleblower retaliation from the Agency's most senior executives.
- 3. The Agency's Assistant Federal Security Director, Mission Support for Minneapolis-St. Paul International Airport forwarded me today an email (EXHIBIT C-22) with a disturbing photo attachment he sent earlier today to the U.S. House Committee on Homeland Security, the U.S. House Committee on Oversight and Governmental Oversight, the U.S. Senate on Homeland Security on Governmental Affairs, Inspector

- General of Department of Homeland Security, John Roth, and the U.S. Office of Special Counsel ("OSC").
- 4. The email attachment is a photo of a December 15, 2014 calendar invitation emailed from the Agency's then-Assistant Chief Counsel/now-Assistant Administrator for the Office of Professional Responsibility ("OPR") Steven Colón to Agency Supervisory Litigation Attorney Jeffrey Velasco and to other employees within the Agency's Office of Chief Counsel ("OCC").
- Mr. Velasco was one of the two Agency attorneys present for my November 5, 2009 hearing before this court.
- Mr. Colón's message to the group writes:

Jeff if you can join us, I would appreciate it.

We already fired Barnett. And I am done being conciliatory with OSC. They have been a nightmare to deal with for the Employment advice folks. They want war, they got one. Unless the evidence stinks. (emphasis added)

- 7. Since May 21, 2015, (EXHIBIT C-23) Mr. Colón has been deeply involved in my case from backpay issues to his rebuffing of all of my invitations to finally begin settlement talks.
- 8. Despite my attorneys providing physical evidence to Mr. Colón proving flagrant and high-level retaliation against me by Agency Headquarters Supervisory Federal Air Marshal ("SFAM") Rose Tancredi, providing him a May 24, 2016 memorandum from OPR Unit Chief Deborah Kearse showing that SFAM Tancredi falsified her November 10, 2016 Equal Employment Opportunity ("EEO") affidavit in entries #14 and #17 by asserting that SFAM Tancredi never had any discussions of racism with me, and pointing out to him in SFAM Tancredi affidavit entry #20 that she declared the person's race was "clearly visible" thus contradicting her privious falsified entries #14 and #17— Mr.

Colón arbitrarily expressed to my attorneys that OPR Unit Chief Kearse may have erred in her findings and again rejected my invitation to begin settlement talks.

9. This is more evidence of Mr. Colón's motivation to place extreme pressure on OPR Unit Chief Kearse to retract her May 24, 2016 conclusion that "SFAM Tancredi expressed that she was offended and believed that the video was racist."
